# Understanding of Stock Exchange of Hong Kong's Findings of the Latest Review of Listed Companies' ESG Disclosures and Main Recommendation & SWCS Research Report 2022 on ESG Performance of Listed Companies

8 February 2023

The Stock Exchange of Hong Kong Limited (the "Exchange") published findings of its latest review of listed companies' ESG disclosures on 25 Nov 2022, which focused on the requirements that came into effect in July 2020 (2020 Enhancements) as set out in the Exchange's ESG Reporting Guide (ESG Rules).

The report gives a useful overview of the compliance level of Hong Kong listed companies in relation to the 2020 Enhancements. It also makes recommendations on boards' governance of ESG issues, climate change and social issues. This seminar will dive in the contents of the report to help companies understand how they are doing compared with their peers and identify areas of improvements.

The seminar will also discuss the findings of a SWCS Report which studies the transparency of ESG information of 334 listed companies over the compliance standards, including mandatory disclosure requirements, governance structure, environmental target setting, climate change and others. Recommendation on best practices will also be shared to help companies achieve better performance in ESG management.
